

Background


Samiti means

The work of Vidyarthi Sahayyak Samiti would have to be viewed as a centre for transformation of the youth; an institution which has transformed the lives of thousands of students. Dr. Achyutrao Apte, Freedom fighter Haribhau Phatak and smt. Sumitratai Kerkar along with others started this mission in 1955 to offer lodging and boarding facilities in Pune at a very concessional cost to students who could not afford higher education due to the high expenses involved. They made a beginning by arranging meals for 5 students. Soon they organised accommodation for the students. Today, Samiti has 5 hostels in Pune where 747 students – boys and girls- are enjoying various facilities.

Samiti is not a mere lodging and boarding; it functions on the following principles –

- Stress on development of personality apart from providing lodging and boarding facilities at very concessional rates.
- 2) Caste, creed, religion are not considered for admission.
- Cleanliness, equality and dignity of labour are the basic principles of all activities.

Admission is granted to only those students who are from rural areas, who are needy and promising but who might have had to discontinue education for lack of financial support.



The Chairman's message

Pratap Pawar

Samiti's hostels have remained closed for over a year and a half due to the Corona restrictions. This brought into focus the problems faced by the students apart from those relating to education and we realised that we need to tackle other fronts also. The first Corona patients in Pune were found in March 2020 which created an atmosphere of fear everywhere. Our generation experienced for the first time how the whole country comes to a standstill due to a lockdown. This impacted all areas including education of students and it is still there.

The students were stuck in their towns as colleges were closed. The phase of college education signifies the threshold of the future career. They being stuck in their homes, the problems of power shortage and mobile network have been affecting their studies. Samiti's students are from the economically marginal strata of society. They meet their expenses by working under the Earn and Learn scheme when they are in Samiti hostels. They could not do this either, as they were stuck in their towns. This increases expenditure and the strain on their parents. So they are trapped between the worry about studies on one side and the increasing financial strain on their families. As a solution, The Ex-students' Association took the lead in starting the Samiti Ashirvad Vruksha scheme. Under this scheme, students were expected to plant indigenous trees in and around their towns. The expense for the saplings, wire cage and a board displaying the donor's name was estimated. It came to about Rs. 1,600/- It was decided to pay Rs. 500/- to the student as stipend under the Earn and Learn scheme for this work. So, donations of Rs. 2,100/- per plant were accepted. About 800 saplings have been planted under this scheme

in various parts of Maharashtra and stipend could be paid to about 100/150 students over about 3-4 months. A Food service –Anna seva – programme was operated by ex-students. Under this scheme, 1.25 lakh meals were provided to labourers, workers and students between April and June. Both the schemes were supported whole heartedly by donors.

Even if students are not there, the daily expenses of the hostels continue. It was also necessary to attend to repairs to the ageing hostel buildings. Planning for this was done during this period. Donors who have been assisting Samiti over generations due to their trust in Samiti sent donations in person or by post or online and this is continuing even now. They trust that every rupee received by Samiti is used only for the transformation of students. Desire for education in girls from rural areas is on the rise. And, because their parents trust Samiti they insist on admitting their girls in Samiti hostels only. We are, therefore, planning to build one more hostel for 250 girls. We have a grateful belief that this would be possible only with support from well wishers like you.



Message from the Managing Trustee

Tukaram Gaikwad



"Was stuck at my native place due to Corona. So helped my mother in farm work. We have a "saavad" system. This means you work in someone else's farm and then , when you need, that person comes to help you in your farm. I did more than 50 "saavad"s like this. So that my mother would get help as many times in future when needed. Now I have to think about further education, look for a job. If I am at my place, people approach with marriage proposals. So I have come to Pune." – Pooja was telling.

When I see her willingness to toil, perseverance and clear thinking about the future, I feel proud that she is a Samiti student. Samiti teaches how to realise your dream by tiding over the present situation. That is why Samiti students are different from others.

The entire current financial year proved to be very bad due to Corona. Students from villages are facing several issues. Samiti is trying to help them through various projects. However, there are constraints in extending help to students whether they are in Pune or at their native places. Still Samiti helped students stuck at their places by going out of the box through a novel "Ashirvaad" tree plantation scheme. Dialogue was maintained with them through digital platforms to keep their morale high. We reassured them through the medium of "Samvaad Pushp" during this tough time and low morale. In line with Samiti's teaching that we owe something to the society, we could offer meals to hungry people through Samiti's "Anna seva" (Food service) project . Our donors generously supported us as usual by appreciating these efforts.

The issues which students face are increasing. Looking at the pace of changes in digital technology, there is a possibility of job opportunities going down in time to come. Hence, while assisting students for higher education, Samiti realises the need to expose them to the alternative of entrepreneurship. We have started efforts in that direction. Savitribai Phule Pune University has assured help for these endeavours. Talks in this regard are on with other organisations also.

While all this was going on, it was necessary to do repairs to the hostel buildings which are several years old. Work of major repairs could be taken up this year as students were away. The number of girls approaching Samiti for admission is increasing. But space is a constraint. Hence, efforts are on to plan and construct a new hostel to accommodate 250 girls. This project is going to cost about Rs. 18 crores. A well wisher of Samiti Shri Vinod Jadhav. Samiti's Trustee Shri Vijay Pusalkar, another Trustee and Executive President of Marathvada Mitra Mandal Shri Bhausaheb Jadhav, Smt. Preeti Rao of Atmaja Foundation have agreed to offer donations for this project and have shown their trust in Samiti's work. Looking at this level of support when the project is still in the approval stage, we are confident that once the work on the ground starts, adequate funds would be received from the society at large to see it through.

Students Selection Process

For students coming to Pune for any branch of studies after passing the 12th grade examination, the process of admission to Samiti starts after they have secured admission to a college. Applications for admission are accepted after they go through the rules and complete the paperwork. This is followed by an interview of the student and his / her parents / quardians. The financial position of the student is verified. If the need and the reason for coming to Pune for education are considered satisfactory, admission is granted. To start with, admission is granted for 6 months and fees for that period only is charged. A comprehensive review is undertaken (conduct of student at Samiti, academic performance, participation in morning yoga session and earn & learn scheme etc) before finalising the provisional admission. Similar review is done for every re-admission of student every year.

Conditions

- Yoga for half an hour is compulsory.
- Should devote half an hour everyday for cleaning or office work.
- Must work in the Earn and Learn scheme to earn enough to meet the expenses on meals.
- Should meet the guardian donor assigned to him once a month.
- Should participate in the programmes of the Students' Development Centre.

Facilities

- 2 to 4 students per room. Each student would be given a cot, a mattress, a cupboard, a table and chair. A fan and hot water for bath.
- A glass of milk after Yoga. and two meals.
- A computer centre, a well stocked Library, a Health Centre.
- Lectures of experts from various fields, Group discussion.
- Study Tours, Visits to various organisations, Educational programmes.
- Various competitions, Cultural programmes.









Activities During the Corona Period



Annaseva (Food service) programme :

The first Corona patient in Pune was found on 9th March 2020 which created an atmosphere of fear. People were confused as nobody had any reliable information about Corona. Suddenly, a nationwide lock down was declared and people experienced what happens when everything throughout the country is closed. Since everything except essential services was closed; students, workers, small traders, labourers suffered tremendously. Samiti's Exstudents' Association came forward. It explored the possibility of providing rice / khichadi to these people. The calculations showed that 100 meals could be offered in Rs. 2,500/- and that this could be done for 100 days if 100 exstudents donated funds to meet the expenses. The programme was launched after taking requisite permissions from the police and the administration. Meals were supplied in several areas like Dhayari, Kondhva, Aundh, Budhavar Peth. The scheme which started with providing 100 to 250 meals per day reached 3,100 meals per day very soon. The Association and Samiti

together provided more than 1,25,000 meals between 30th March and 8th June 2020. Several newspapers and TV channels took note of this. The Kalyani group, Sakal Relief Fund, Sava Pharmaceuticals, Marathvada Mitra Mandal and others extended a helping hand. A small booklet on this project titled "Samskarateel Samvedana" was published.



Samiti Ashirvad Vruksha Yojana (Samiti 'Blessings by Trees' Scheme):

Students who returned to their native places in March 2020 due to the Corona outbreak, were stuck there. It was hoped that colleges would reopen and Samiti's operations would return to normal once the restrictions were relaxed in June 2020. But the epidemic kept spreading and the students could not return to Pune during the entire year.

When in Samiti, the students can meet some personal expenses through the Earn and Learn Scheme. However, since they were stuck in their villages, they were short of money. Even charging mobile phones became difficult. This prompted Samiti to launch the Ashirvad Vruksha Scheme. The sapling is already grown to 3 to 4 feet height. The responsibility of planting the sapling and looking after it is taken by the student and his family. Photos of the sapling are sent to the donor from time to time as it grows. Providing a protective mesh, support stick, a small templet bearing the number of the sapling and the name of the donor cost Rs. 1,600 while the stipend of Rs. 500 to the student under the Earn and Learn scheme meant a total expense of Rs. 2,100 per sapling. 620 saplings were planted under this scheme in Pune, Solapur, Vidarbha and Marathvada. Very good response was received from the donors for this scheme.

The donors felt that when Ex students Association and Samiti were taking initiative for protection of the environment, they should be with them. M/s Kalyani Techno Forge offered substantial financial support for this scheme.

Samvad Pushp (Dialogue Forum):

All activities of Samiti were inoperative since all the students were at their villages. In order to maintain dialogue with the students and maintain their morale, experts from various fields had a dialogue with them via digital media once a month through the Samvad Pushp forum.

Participation of Ex-students in the Palya-Palak scheme (Guardian-ward programme):

Palya-Palak is a quite different scheme of Samiti and is compulsory for students. The idea is that each student should meet one of Samiti's donors once a month. The donors are considered as guardians of the students. As far as possible, guardians are assigned so that the background of the guardian and the branch of study of the student match. This scheme enables a student from rural background to visit a family from a city and familiarise with their way of living and also get useful guidance from an elderly and experienced person. This also enables the guardian to keep abreast of the developments in Samiti and keep in touch with the progress of the student. Efforts are on to ensure maximum participation by ex-students in this scheme. Samiti intends to insist that the ex-student or his / her spouse should become a member in this scheme by paying Rs. 3,000/- for a year. It has been observed that the success, experience and guidance of the ex-students prove very beneficial for the students.



Memory



Renovation of Dr. Achyut Apte Hostel

Since this building is about 41 years old and frequent repairs are needed, it was decided to carry out all the repairs at one time. This was possible since there were no students. The work started in October 2020 and was completed by end July 2021.

A big Donation from Marathvada Mitra Mandal

There are plans to do some construction in Samiti's open space. Keeping in mind the pressing need for additional accommodation for girls, we are going to construct a hostel to accommodate 250 girls. On learning this, Marathvada Mitra Mandal promptly announced a donation of Rs. 2.50 crore for 25 rooms of the hostel.

Six Sigma

A Six Sigma workshop was organised for engineering students this year also. The response was good. All the students also got placement after graduation.

Annual Calendar :

For the first time, a calendar presenting information about Samiti has been published. 3000 copies printed on art paper were distributed. Ex-students booked advertisements to meet the expenses so that there was no burden on Samiti.

On learning about Samiti's activities, Shri Abhijit Datar and Smt. Aboli Mahajan of Cognizant arranged for a donation of 100 computers by the company. Shri Nikhil Nanivadekar also helped in this matter. They are also trying to conduct some programmes relating to skill development, for Samiti students.

Got life's Provision

I spent my childhood at Shivpuri (Taluka Malshiras). Father was a trader selling onions and potatoes. Mother worked in Sheti Mahamandal on daily wages. Ours was a large family with five daughters and four sons. Could just manage the daily needs. Completed education till 10th standard while tending to cattle. Got 75 % marks in the 10th grade examination. Passed the 12th exam with good marks and got admission for the Surface Coating course and to Samiti. The three years in Samiti equipped me with life's provisions. The various programmes in Samiti were extremely useful for development of personality. Got a job in Asian Paints after completing Diploma. Set up Consultech Engineers in 1998 and started manufacturing painting booths and powder coating systems. Set up a new company : "Tech-expert Engineering", in 2016. It has now become an international brand. It produces paint finishing systems, shot blasting systems, automatic finishing systems. Tech-expert floated a joint venture in 2017 in collaboration with GB Neuhaus, Germany in the field of nano coating technology. Now more than 100 employees are working in the group. Samiti has a very important share in this success. Circumstances taught me much while I was a student which made it possible to reach this stage. I am now the President of Samiti's Ex-students' Association.

A Loan which cannot be repaid

Got admission for civil engineering in COEP, Pune after the 12th grade. While enquiring about accommodation, Prof. M.R. Khadilkar from the college (a Guardian from Samiti) told me about Vidyarthi Sahaayyak Samiti. Shri Rajabhau Patvardhan and Shri Yadavarao Kulkarni of Samiti interviewed me and I was admitted. Had I not got admission here I would have been compelled to cancel my college admission. Learnt a lot from Smt. Sumatitai Patkar, a strict disciplinarian. Developed friendship with other girls while doing yoga, four-hours work, Marathi English group discussion, weekly common cleaning up. Even today, I have maintained the habits of cleanliness, self reliance, helping others in their hour of need and performing yoga regularly. Got permanently connected with the families of Jayashreetai Bhide, Prof. Khadilkar, Dr. Deshpande. Got opportunity to learn a lot from great persons like Apte sir, Nirmalatai, Sumitratai. After passing B.E.(Civil), did M.E.(Civil) while working, got Ph.D. from I.I.T., Roorkee. However, I value more the degree of "Exstudent of Samiti". Presently working in the civil engineering department at COEP, Pune as an Associate Professor. Lot of credit for what I am today goes to Samiti. Samiti's obligations are not repayable.

Audit Report

To The Board of Trustees, Vidyarthi Sahayyak Samiti, 1184/1/4 F.C. Road, Pune 411 005.

As per our appointment, we have audited the attached Balance Sheet of Vidyarthi Sahayyak Samiti as at **March 31, 2021** and also the Income and Expenditure Account for the year ended on that date annexed thereto. These financial statements are prepared by incorporating the accounts of the Trust.

These financial statements are the responsibility of the Management. Our responsibility is to express an opinion on these financial statements based on our audit. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain the reasonable assurance about whether the financial statements are free of material misstatements. An audit includes examining evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

We further report that :

- a) We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purposes of our audit.
- b) The Balance Sheet and Income & Expenditure Account dealt with by this report are in agreement with the books of account.
- c) In our opinion, the Trust has kept proper books of account as required by law so far as it appears from our examination of these books.
- In our opinion the Balance Sheet and Income & Expenditure Account comply with relevant Accounting Standards, exceptions mentioned in respect AS-9 on Revenue Recognition.
